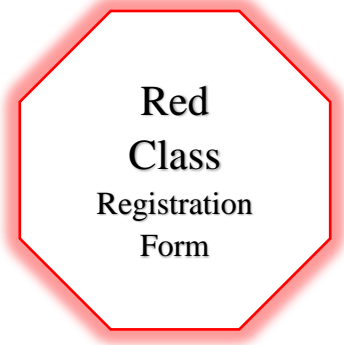

- Students seventeen years of age and under are required by the State of Virginia to complete a state approved driver's education program prior to receiving a driver's license. The requirement for the classroom instruction is thirty-six fifty-minute periods. (30 hours)
- A refund will only be given if Green Light is incapable of or unwilling to perform its part of this agreement within one hundred twenty days of registration.
- The instruction provided by this school does not guarantee that any student will pass the state license examination or that the student can secure a driver's license or the student will be guaranteed employment upon completion of course.
- All tardiness and absences will need to be made up. You must attend the first class scheduled. Students can usually make up a class next time a class is being offered. Please check with Green Light to confirm make up dates.
